Bow Valley College is licensed to deliver this course as part of the Government of Alberta Health Care Aide Provincial Curriculum 2019.

Work integrated learning provides learners with a comprehensive learning experience in an organizational setting. During work integrated learning experiences, learners are provided with the valuable opportunity to apply knowledge gained in the classroom and lab settings and build confidence in their health care aide practice.

Many practicum and clinical sites have multiple shifts. Learners can expect clinical shift times to vary; days, evenings, nights, and weekend shifts may be required. A variety of clinical locations are used, including rural settings. For instructor led clinicals, the department will place learners. No changes can be made. With respect to mentorship, the clinical placement team will meet with learners towards the end of the program to discuss options. Learners are responsible for providing their own transportation to and from work integrated learning locations. While the department does its best to secure clinical and mentorship placements for all eligible learners, placements for each learner are not guaranteed and in rare instances,



there may be a delay in program completion until a clinical placement can be arranged.
